Sundaram Ever since Professor Henry Manne coined the phrase the market for corporate control in 1965, the phenomenon of mergers & acquisitions (M&A) has been closely associated with corporate governance.¹ In his article, Manne (1965, p. 113) developed a straightforward argument that, by hindsight, seems obvious: The lower the
